## International Student Affidavit of Support

This Affidavit of Support is used as a detailed statement of financial resources. It must be accompanied by a bank statement. This indicates that you have sufficient funds to finance your education at Midlands Technical College. This form must indicate how much money, in U.S. dollars, will be available to you **per year** to meet the cost of your education. It must also provide the source of the money. You are required to deposit **\$10,449** in an escrow account at Midlands Technical College to cover the estimated cost of your tuition and student fees for your first two semesters.
