| Not Maintaining 70%/GPA | 70%/GPA – SAP | Need to do an Appeal to regain financial aid eligibility |
| Attempted 180 Hours | SAP ineligibility | Need to do an Appeal to regain financial aid eligibility |
| Not Meeting GPA | 70% – SAP | Need to do an Appeal to regain financial aid eligibility |
| Maximum Timeframe | 150% of Program | Need to do an Appeal to regain financial aid eligibility |
