Yesterday, the conference room was 2' x 4' but the rest of the space was 2' x2'. Are we to still demo and replace all the ceiling grid and tile?</p> <p><b><u>Response:</u></b></p> <p>All existing ceilings shown in blue and dashed are to be demolished as shown at AD-110. The board room (conference room) does have 2x4 ceilings tiles existing. The renovation plans shows new 4x4 ceiling tiles with the existing perimeter soffit to remain. All other rooms show new 2x2 ceiling grids or gwb soffits as shown at the renovation plans on AE-110. This is the design intent. Please include in your price, installing new <math>\frac{1}{4}</math>" layer of gwb to the horizontal surface of this soffit to provide a new even surface and reduce patching around new lighting fixtures to be installed at the new soffit.</p>
