ADMISSION CRITERIA FOR APPLICATION

- 1. <u>MUST complete all prerequisite courses with a C or higher prior to submitting application.</u> No exceptions will be made.
- 2. Prerequisite GPA must be 2.5 or higher. **GPA Calculator**
- 3. Students who have failed a prerequisite course more than once, or have failed more than two prerequisite courses, are not eligible to apply.
- 4. All math and science prerequisite courses must have been taken within 5 years of anticipated program entry.

DENTAL HYGIENE ACCEPTANCE REQUIREMENTS

AFTER receiving notification of acceptance, only those students who are accepted into the program will receive instructions from the program director concerning requirements that must be completed before the first day of fall classes. These include:

- Three mandatory orientation sessions
- Out-of-pocket expenses: background check and drug screening, CPR, uniforms, supplies, physical exam and required immunizations.
- Dental cleaning by a MTC Dental Hygiene senior student.
- Six (6) hours of unpaid volunteer community service.
